- Matters / correspondence arising / Materion / gohebiaeth yn codi:

a. Housing Support Letter – Clerk contacted resident who confirmed that a letter would no longer be required as they have been offered a property which suits their requirements in another area / Llythyr Cymorth Tai – Cysylltodd y clerc â'r preswylydd a gadarnhaodd na fyddai angen llythyr mwyach gan eu bod wedi cael cynnig eiddo sy'n addas i'w gofynion mewn ardal arall.

b. NEST Pension – Clerk informed, that under the Pensions Act 2008, and as an employee of LCC, she has to be an active member of an automatic enrolment scheme. SLCC guidance recommends NEST. Clerk has enrolled LCC onto NEST and contributions will be 4% Employer and 4% employee, starting as from April 2026. This was discussed in a previous meeting and all Cllrs agreed. Clerk has printed a copy of the Terms and Conditions for Cllrs to read / Pensiwn NEST – Hysbysodd y Clerc, o dan Ddeddf Pensiynau 2008, ac fel gweithiwr i LCC, fod yn rhaid iddi fod yn aelod gweithredol o gynllun cofrestru awtomatig. Mae canllawiau SLCC yn argymhell NEST. Mae'r Clerc wedi cofrestru LCC ar NEST a bydd y cyfraniadau'n 4% Cyflogwr a 4% gweithiwr, gan ddechrau o fis Ebrill 2026. Trafodwyd hyn mewn cyfarfod blaenorol a chytunodd yr holl Gynghorwyr. Mae'r Clerc wedi argraffu copi o'r Telerau ac Amodau i'r Cynghorwyr eu darllen.

c. Clerk received updated version of the Finance and Government Toolkit which gives guidance and support to ensure that Town Councils are meeting statutory requirements that are expected by auditors and public.
