**5087/23** – Red Lion, Definitive Map Modification . Meeting to be held on 19<sup>th</sup> January 2023 at 11.30am in Llangadog Community Centre with Mr Mike Taylor (Access Countryside). Cllr Haulwen Booth, Cllr Wyn Jones, Cllr Dafydd Morgan and Cllr John Hampson to attend meeting / Red Lion, Addasiad Map Diffiniol . Cyfarfod i'w gynnal ar 19 Ionawr 2023 am 11.30yb yng Nghanolfan Gymunedol Llangadog gyda Mr Mike Taylor (Access Countryside). **5090/23** – Minuted 5069/22 Concerns from local resident re footpath issues from corner of Vicarge Road and Walters Road being impassable. Cllrs agreed that Clerk to contact Mr Jason Lawday, to ensure that the issue is resolved at the earliest opportunity / Cofnod 5069/22 Mynegwyd pryder gan breswlydd lleol na ellir tramwyo dros y llwybr troed o gornel Vicarage Road a Walters Road Cytunodd y Cynghorwyr fod Clerc i gysylltu â Mr Jason Lawday, i sicrhau bod y mater yn cael ei ddatrys cyn gynted â phosibl

**5091/23** – Cllrs agreed that the issue in regards to the double yellow lines in Llangadog Village to be followed up, by County Councillor Andrew Davies. Clerk to email County Councillor Andrew Davies to confirm that a site meeting to be arranged with Mr Andrew Morgan (Traffic Engineer) at the earliest opportunity / Cytunodd y Cynghorwyr fod y mater o ran y llinellau melyn dwbl ym Mhentref Llangadog yn cael eu dilyn, gan Gynghorydd Sir Andrew Davies. Y Clerc i anfon e-bost at y Cynghorydd Sir Andrew Davies i gadarnhau y dylid trefnu cyfarfod safle gyda Mr Andrew Morgan (Peiriannydd Traffig) cyn gynted â phosibl.

**5092/23** – Minuted 5068/22 – Faulty Street Light, Ivorite Cottage. Clerk to contact Mr Arwel Price to get an estimated costs of the work involved and Cllr Wyn Jones to organise groundworks operative. Clerk to inform Cllrs when estimated costings have been received / Cofnod 5068/22 – Golau Stryd diffygiol, Ivorite Cottage. **5093/23** – Invoice received from CCC for charges made on remedial works completed at the Llangadog Playground in September, following the CCC inspection. It was agreed by all Cllrs that as no one had been notified of the works by CCC, Cllr John Hampson would inspect the playground to ensure the work has been completed and to a satisfactory standard before payment can be released. Cllr John Hampson to contact Clerk when inspection has been completed / Derbyniwyd anfoneb gan CCC ar gyfer taliadau a wnaed ar waith adferol a gwblhawyd ar Faes Chwarae Llangadog ym mis Medi, ar ôl i'r CCC archwilio. **5094/23** – Email from County Councillor Andrew Davies re Warm Hub Spaces within the Community was discussed further and no applications for funding are to be made within the Community areas / Trafodwyd e-bost gan y Cynghorydd Sir Andrew Davies re Gofod Cynnes o fewn y Gymuned ymhellach ac nid oes unrhyw geisiadau am arian i'w gwneud o fewn yr ardaloedd Cymunedol.

**5095/23** – Minuted 5071/22 Legal Obligation for Website. Clerk informed that Orchardweb will change ownership of the current community website directly to Llangadog Community Council as from 1<sup>st</sup> January 2023. Confirmation was given that Orchardweb will continue to host the website at a yearly cost as previously and Cllrs require guarantee of change of ownership and registration. Clerk to contact Orchardweb to confirm that the changes have been made. It was also agreed that no further updates to the current website to be made other than updating the Llangadog Community Council link, and that in the future, the Council could look at involving other community groups /school etc, on the website, for a small charge to cover the hosting of the

website. Clerk to continue to liaise with Orchardweb / Cofnod 5071/22 Rhwymedigaeth Gyfreithiol ar gyfer Gwefan. Dywedodd Clerc y bydd Orchardweb yn newid perchnogaeth ar wefan bresennol y gymuned yn uniongyrchol i Gyngor Cymuned Llangadog o 1 Ionawr 2023. Rhoddwyd cadarnhad y bydd Orchardweb yn parhau i gynnal y wefan ar gost flynyddol fel o'r blaen ac mae angen gwarant i Gynghorau newid perchnogaeth a chofrestru. Clerc i gysylltu â Orchardweb i gadarnhau bod y newidiadau wedi'u gwneud. Cytunwyd hefyd nad oedd unrhyw ddiweddariadau pellach i'r wefan bresennol i'w gwneud ar wahân i ddiweddaru cyswllt Cyngor Cymuned Llangadog, ac y gallai'r Cyngor yn y dyfodol edrych ar gynnwys grwpiau, ar y wefan, am dâl bychan i dalu am gynnal y wefan. Clerc i barhau i gysylltu â Orchardweb

**5096/23** – Clerk to complete form received from CCC on details of any bus shelters within our ownership. Cllr Wyn Jones confirmed that there is only one bus shelter in Bethlehem. Clerk to complete and send off form to CCC / Clerc i gwblhau ffurflen a dderbyniwyd gan CCC ar fanylion unrhyw lochesi bws o fewn ein perchnogaeth. Cadarnhaodd y Cynghorydd Wyn Jones mai dim ond un lloches bws sydd ym Methlehem. Clerc i gwblhau ac anfon ffurflen i CCC.

**5097/23** – Council Tax Base and Precept requirement. Clerk confirmed that CCC require notice of our required precept for 2023/2024 is required no later than 31<sup>st</sup> January 2023. Cllrs discussed further precept amount and it was agreed due to increase in expenditure ie training requirements for Cllrs and Clerk, SCRIBE Accounting Package, website, that the amount for this year to be £21,000.00 an increase of £1,000 only. Clerk completed form and Cllr Haulwen Booth (Chair) signed the Precept Form. Clerk to scan and email to CCC as soon as possible / Sylfaen Treth y Cyngor a gofyniad Praesept. Cadarnhaodd clerck fod angen hysbysiad o'n praesept gofynnol ar gyfer 2023/2024 ddim hwyrach na 31 Ionawr 2023. Trafododd y Cynghorwyr swm praesept pellach a chytunwyd oherwydd cynnydd yn y gofynion gwariant hy hyfforddiant ar gyfer Cynghorwyr a Chlerc, Pecyn Cyfrifeg SCRIBE, gwefan, bod y swm ar gyfer eleni yn £21,000.00 a chynnydd o £1,000 yn unig. Llenwyd y ffurflen Praesept gan y Clerc a'i llofnodi gan y Cyng Haulwen Booth.

**5098/23** – Cllr Wyn Jones informed that there is work required in Llangadog Lawn Cemetery., this being the updating of the current plans/layout of the cemetery and removal of the current roundabout / Dywedodd y Cynghorydd Wyn Jones bod gwaith yn angenrheidiol ym Mynwent Lawnt Llangadog., angen ddiweddaru cynlluniau/cynllun presennol y fynwent a chael gwared ar y gylchfan bresennol.
