**5238/23** – Previous meeting minutes dated 4<sup>th</sup> July 2023 were proposed correct by Cllr John Hampson and seconded by Cllr Jennifer Hughes / Cynigiwyd cofnodion cyfarfod blaenorol dyddiedig 4 Gorffennaf 2023 yn gywir gan y Cynghorydd John Hampson ac eiliwyd hwy gan y Cynghorydd Jennifer Hughes.

**5239/23** – Traffic Calming (Ger yr Ysgol) – County Cllr Andrew Davies had a request from local parent, after distressing incident that had recently taken place and the serious concerns raised of children playing in and around the road vicinity of Ysgol Llangadog. Further discussions were had about utilising the area behind the school car park and updating the playground. It was agreed that letter(s) should be sent of the current issues and the need for relevant signage and nominated area(s) for children to play in this area. County Cllr Andrew Davies and Clerk to send letter to Ms Wendy Walters as a matter of urgency. Cllr Dafydd Morgan to support Clerk with relevant details to be put into letter / Tawelu Traffig (Ger yr Ysgol) – Cafodd y Cynghorydd Andrew Davies gais gan riant lleol, ar ôl digwyddiad trallodus a ddigwyddodd yn ddiweddar a'r pryderon difrifol a godwyd o blant yn chwarae yng nghyffiniau ffordd Ysgol Llangadog a'r cyffiniau. **5241/23** – Community Website – Cllr Dafydd Morgan to contact Orchardweb to organise zoom meeting / - Gwefan Gymunedol – Cyng Dafydd Morgan i gysylltu â Orchardweb i drefnu cyfarfod ar lein.

**5242/23** – Llangadog Community Centre – Cllr Dafydd Morgan attended first meeting of the new Committee formed for Llangadog Community Centre, to give information on what support Llangadog Community Council could give, to the Committee, if lack of support and income put the Hall in jeopardy of closing. No further action is required unless further contact made by Committee / Canolfan Gymunedol Llangadog – Mynychodd y Cynghorydd Dafydd Morgan gyfarfod cyntaf y Pwyllgor newydd a ffurfiwyd ar gyfer Canolfan Gymunedol Llangadog, i roi gwybodaeth am ba gymorth y gallai Cyngor Cymuned Llangadog ei roi, i'r Pwyllgor, pe bai diffyg cefnogaeth ac incwm yn peryglu'r Neuadd i gau. Cllrs discussed and it was agreed that at this time they are unable to help, as this could then entail supporting other chapels / churches within the ward areas.
