5196/23 – Previous meeting minutes dated 2nd May 2023 proposed as correct by Cllr Wyn Jones and seconded by Cllr Jennifer Hughes / Cofnodion cyfarfod blaenrol dyddiedig 2 Mai 2023 cynigiwyd fel rhai cywir gan y Cynghorydd Wyn Jones ac eiliwyd gan y Cynghorydd Jennifer Hughes

5197/23 – AGM Minutes dates 2nd May 2023 approved by Cllr John Hampson and seconded by Cllr Aaron Hughes / Cyfarfod Cyffredinol Blynnyddol a gynhaliwyd ar 2 Mai 2023 cymeradwywyd gan y Cynghorydd John Hampson ac eiliwyd gan y Cynghorydd Aaron Hughes

5198/23 – Certificates from One Voice Wales for the Induction for New Councillors and Code of Conduct were received for all Cllrs. It was agreed that these should be placed onto the website. Clerk to send to Orchardweb for inclusion / Derbyniwyd tystysgrifau gan Un Llais Cymru ar gyfer Sefydlu Cynghorwyr Newydd a'r Cod Ymddygiad ar gyfer pob Cynghorydd. Cytunwyd y dylid rhoi'r rhain ar y wefan. Clerc i'w anfon i Orchardweb i'w gynnwys.

5199/23 – Footpath issues with Vicarage Road and Walters Road. Site meeting with Cllr Dafydd Morgan and Jason Lawday on 11th May 2023. To make the footpath wider would require agreement with the landowner as well as moving the current fencing. Matting could be placed in the main areas to help with the mud issues, this being by the "kissing gate" and the 2nd field. This would also include a maintenance scheme. Suggestion was made to apply for the Major Improvement Scheme to improve / upgrade the current footpath. Clerk to contact Jason Lawday to request further information on this scheme / Materion llwybr troed gyda Vicarage Road a Heol Gwallter. Cyfarfod safle gyda'r Cynghorydd Dafydd Morgan a Jason Lawday ar 11 Mai 2023. Er mwyn gwneud y llwybr troed yn ehangach byddai angen cytundeb gyda'r tirfeddiannwr yn ogystal â symud y ffensys presennol. Gellid rhoi mating yn y prif feysydd i helpu gyda'r materion mwd, sef wrth y "gatiâu mochyn" a'r ail gae. Byddai hyn hefyd yn cynnwys cynllun cynnal a chadw. Gwnaed awgrym i wneud cais am y Cynllun Gwelliant Mawr i wella / uwchraddio'r llwybr troed presennol. Clerc i gysylltu â Jason Lawday i ofyn am ragor o wybodaeth am y cynllun hwn

5200/23 – Ivorite Cottage, Faulty Street Light. Site visit with Cllr Wyn Jones and Arwel Price on 29th May 2023. The current pole that secures the lighting is not the property of Western Power. It was agreed that CCC would complete the works which would include digging the trench and then placing new light on original pole. Clerk to keep update on this / Ivorite Cottage, Golau Stryd Diffygiol. Ymweliad safle gyda'r Cyngorydd Wyn Jones ac Arwel Price ar 29 Mai 2023. Nid yw'r polyn presennol sy'n diogelu'r golau yn eiddo i Western Power. Cytunwyd y byddai CSG yn cwblhau'r gwaith gan gynnwys cloddio'r ffos a rhoi golau newydd ar y polyn gwreiddiol. Clerc i gadw'r wybodaeth ddiweddaraf am hyn.

5201/23 - Red Lion Definitive Map. No further update to report on / Red Lion Map Diffiniol. Dim diweddariad pellach ar hyn.

5202/23 – Remedial works Llangadog Playground. Quote received from CCC to cover resecuring of bench legs to ground, replace missing timber slats on bench and repairs. Also included, free of charge, repair to the low rotator rubber surface as not currently to standard / Gwaith Adferol ar Faes Chwarae Llangadog. Dyfyniad a dderbyniwyd gan CSG i gynnwys adfer coesau mainc i'r llawr, ail osod slatiau pren coll ar y fainc ac atgyweirio. Hefyd yn rhad ac am ddim, atgyweirio i'r wyneb rwyber rotator isaf gan nad yw ar hyn o bryd i'r safon disgwylidig.

5203/23 – Traffic Calming Issues – 'Ger yr Ysgol' Estate. No further updates / Problemau Tawelu Traffig – Ystâd 'Ger yr Ysgol'. Dim diweddariadau pellach.

5204/23 – HM Land Registry – Carreg Sawdde Common. Awaiting Title map. Cllrs agreed for Clerk to make contact with June Stait to get any further information on the Common. No reply from Commons Officer (CCC) to date, County Cllr Andrew Davies agreed to follow this up / Cofrestrfa Tir EM – Comin Carreg Sawdde. Aros am Deitl map. Cytunodd y Cyngorwyr i'r Glerc gysylltu â June Stait i gael unrhyw wybodaeth bellach am y Comin. Dim ateb gan Swyddog Tiroedd Comin (CSG) hyd yn hyn. Cytunodd y Cyngorydd Andrew Davies i ddilyn hyn i fyny.

5205/23 – Community Website – Cllrs agreed that a meeting to be set up with Orchardweb and Cllr Dafydd Morgan to have further discussions on updating the current website. 5210/23 – Cllr Dafydd Morgan informed the Cllrs that Estyn Report has been published for Ysgol Llangadog and that the report was very good. There were no major issues / points for consideration / - Dywedodd y Cynghorydd Dafydd Morgan wrth y Cynghorwyr fod Adroddiad Estyn wedi ei gyhoeddi ar gyfer Ysgol Llangadog a bod yr adroddiad yn dda iawn. Nid oedd unrhyw faterion / pwyntiau pwysig i'w hystyried.

5211/23 – Email from CCC (Head of Administration & law) re Nant Milhil Energy Park requesting that any dispensations from any Cllrs on the said project should be made in writing. Clerk to respond to request 3 x dispensations / E-bost gan CCSG (Pennaeth Gweinyddiaeth a'r Gyfraith) Parc Ynni Nant Milhil yn gofyn i unrhyw ollyngiadau gan unrhyw Gynghorwyr ar y prosiect hwn gael eu gwneud yn ysgrifenedig. Clerc i ymateb i ofyn am 3 x gollyngiadau.


5217/23 – Items requiring a decision relating to / Eitemau sydd angen penderfyniad yn ymwneud â:
