Reply received 9<sup>th</sup> February from Mr Stuart Quick confirming works will commence on resurfacing once confirmation from Network Rail on suitable traffic control. Works are planned for March 2023. Clerk to monitor situation / Munud 5115/23 a 5100/23 - Gwaith wyneb y ffordd tu allan i Wynstay/Canolfan Arddio a Bwydydd Anifeiliaid Anwes Cambrian. No further action required at this time / Munud 5123/23 – Caniatâd Cynllunio 23/21733/Datblygiad FUL Canolfan Llesiant Ysgol Goedwig. Llythyr o wrthwynebiad wedi'i anfon i'r Adran Gynllunio. Nid oes angen gweithredu pellach ar hyn o bryd.

**5137/23** – Cllr Dafydd Morgan attended a School Governors Meeting at Ysgol Llangadog. Confirmed that they are in the process of advertising for a new School Headteacher / Y Cyng Dafydd Morgan wedi mynychu cyfarfod llywodraethwyr yr ysgol yn Ysgol Llangadog. Cadarnhawyd bod yr ysgol yn y broses o hysbysebu ar gyfer Pennaeth newydd i'r ysgol.

**5138/23** – County Councillor Andrew Davies confirmed that an Engineer had been to inspect the Tywi bridge due to previous flooding issues and that no further works required as there was no apparent blockage. Situation to be monitored. **5139/23** -County Councillor Andrew Davies confirmed a review of specialist consultants was in progress to allow work to commence on repairing Brân Bridge. Work is expected to be completed by the Summer. Situation to be monitored with any updates given to Cllrs / Cadarnhaodd y Cynghorydd Sir, Andrew Davies, bod adolygiad gan ymgynghorwyr arbenigol ar y gweill i ganiatáu i'r gwaith ddechrau ar atgyweirio Pont Brân. Mae disgwyl i'r gwaith gael ei gwblhau erbyn yr Haf. Sefyllfa i'w monitro gydag unrhyw ddiweddariadau i'w cyflwyno i'r Cynghorwyr.

It was agreed that the Cllrs should be involved with supporting the objections as the Community Council. Clerk also informed that a letter had been received from Adam Price AS/MS & Cefin Campbell AS/MS requesting support from local Community in signing a petition to be used in communications with Bute Energy. Cllr Dafydd Morgan agreed to hold the petitions in the Post Office and Clerk to advertise on Community FB page and Community Website / Dywedodd y Cynghorydd John Hampson wrth y Cynghorwyr ei fod wedi ymuno â Grŵp Llywio Llandeilo (Dyffryn Tywi yn Erbyn Peilonau). Diweddarodd y Cynghorwyr ar wybodaeth a gasglwyd o fynychu'r Cyfarfod Ymgynghori a gynhaliwyd yn Llandeilo ar y Peilonau Ynni Bute arfaethedig. Cytunwyd y dylai'r Cynghorwyr fod

yn rhan o gefnogi'r gwrthwynebiadau fel y Cyngor Cymuned. Dywedodd y Clerc bod llythyr wedi'i dderbyn gan Adam Price AS/MS & Cefin Campbell AS/MS yn gofyn am gefnogaeth gan y Gymuned leol wrth lofnodi deiseb i'w defnyddio wrth gyfathrebu â Ynni Bute. Cytunodd y Cyng Dafydd Morgan i ddal y ddeiseb yn Swyddfa'r Post a'r Clerc i hysbysebu ar dudalen FB Cymunedol a'r Wefan Gymunedol.




**5150/23** – No items were given for the next agenda / Ni roddwyd unrhyw eitemau ar gyfer yr agenda nesaf
