### Agenda Items

**5334/24** – Apologies from Cllr Hugh Davies and Cllr Dafydd Morgan. Cllr Alan Price chaired the meeting.

**5335/24** – Declaration of Interest – No declaration of interests.

**5336/24** – Previous meeting minutes dated 5<sup>th</sup> March 2024 approved by Cllr Aaron Hughes and seconded by Cllr John Hampson.

**5337/24** – To receive Councillors reports on events and meetings attended on behalf of the Council – no reports or events attended.

**5338/24** – Regional Transport Plan for South West Wales – all Cllrs have received information via email and any initial comments will be made on line.

**5339/24** – Clerk informed that the accounts have now been closed for 2023/2024 on SCRIBE. All Cllrs received a copy of the Accounting Statement and was approved by all Cllrs. Clerk to forward all relevant documentation to Accountant for auditing.
