**5321/24** – Ramblers Cymru – Cllrs further discussed request for volunteers to help record/report details of paths, stiles, gates and signage on any rural paths and bridleways that may not be known on the Countryside Access Management System. It was agreed that there were no issues but to report the details of the Red Lion Definitive Map, that is currently being approved / Cerddwyr Cymru – Bu'r Cynghorwyr yn trafod ymhellach y cais am wirfoddolwyr i helpu i gofnodi/adrodd manylion llwybrau, camfeydd, gatau ac arwyddion ar unrhyw lwybrau gwledig a llwybrau ceffyl nad ydynt efallai'n hysbys ar y System Rheoli Mynediad i Gefn Gwlad. Cytunwyd nad oedd unrhyw faterion ond i adrodd am fanylion Map Diffiniol Red Lion, sy'n cael ei gymeradwyo ar hyn o bryd

**5322/24** – Draft Modernising Education Programme (MEP) – it was suggested that Cllrs should read the documentation on the CCC website and to submit any views by no later than 12<sup>th</sup> March 2024 / Rhaglen Moderneiddio Addysg Ddrafft (MEP) – awgrymwyd y dylai'r Cynghorwyr ddarllen y ddogfennaeth ar wefan CSC a chyflwyno unrhyw farn erbyn 12 Mawrth 2024 fan bellaf.

**5323/24** – Community Noticeboard / Defibrillator – Both have been removed due to the current refurbishment of the Castle Hotel. A new heated defibrillator has been purchased and it was agreed that the new site would be by the Post Office. Cllr Dafydd Morgan to organise installation. Clerk informed that it was not a legal requirement to have a noticeboard, but would liaise with the Community Hall to agreed if minutes can placed on the noticeboard within the foyer area / Hysbysfwrdd Cymunedol / Diffibriliwr - Mae'r ddau wedi'u tynnu oherwydd y gwaith adnewyddu presennol ar Westy'r Castell. Mae diffibriliwr gwres newydd wedi'i brynu a chytunwyd y byddai'r safle newydd wrth Swyddfa'r Post. Y Cyng Dafydd Morgan i drefnu gosod. It was agreed that RFC Floodlights be reduced by 20% and the 4 x benches reduced by 10%. **5333/24** – Cllr Haulwen Booth reported that the issues relating to the land subsidence on the A4069 just beyond Three Horseshoes is getting worse and to report again. Further along the A4069 opposite Pencae Du Cottage – a pipe under the gate way is blocked – it has been seen too but needs further attention. The bridge Nr Jerusalem chapel and Glanrhyd Cottage needs to be inspected. Cllr Aaron Hughes reported potholes by the small holding at Carreg Sawdde. Pothole needs attention near Bailey Dyffryn Farm in Bethlehem. To be inserted onto list of

outstanding issue to County Cllr Andrew Davies / Dywedodd y Cyng Haulwen Booth bod yr ymsuddiant tir ar yr A4069 ychydig y tu hwnt i'r Three Horseshoes yn gwaethgu ac i adrodd eto. Yn uwch i fynnu'r A4069 gyferbyn â Pencae Du mae pibell wedi'i rhwystro – mae wedi'i weld ond angen sylw pellach. Mae'r bont sy'n agos i gapel Jerwsalem a Glanrhyd yn Gwynfe angen ei arolygu eto. Adroddodd y Cyng Aaron Hughes bod tyllau ger y tyddynnod yng Ngharregsawdde. Tyllau ffordd ger FFerm Bailey Dyffryn yn Bethlehem. I'w gynnwys ar y rhestr o faterion sy'n weddill i'r Cynghorydd Sir Andrew Davies.
