5307/24 – Community Public Access Defibrillators – further discussions were had in
regards to the Defibrillators situated at the Llangadog Rugby Club, Queens Square
(LLangadog), Llangadog Community Centre, Gwynfe and Bethlehem. It was agreed
that: / Mynediad Cyhoeddus Cymunedol i'r Diffibrilwyr– cafwyd trafodaethau pellach
ynghlŷn â'r Diffibrilwyr a leolir yng Nghlwb Rygbi Llangadog, Sgwâr y Frenhines
(LLangadog), Canolfan Gymunedol Llangadog, Gwynfe a Bethlehem. Cytunwyd bod:

Llangadog RFC – Cllr Alan Price would inform Committee that the defib was last
checked in 2021 and that there has been no update on the Circuit account / Bod y
Cyng Alan Price yn mynd i hysbysu'r Pwyllgor fod y defib wedi'i wirio ddiwethaf yn
2021 ac nad oedd unrhyw ddiweddariad wedi bod ar y cyfrif Cylchdaith.

Gwynfe – Cllr Haulwen Booth to check that there is a responsible Guardian as well


