**5608/25**– Apologies / Ymddiheuriadau – from Cllr Hugh Davies / oddi wrth y Cyng Hugh Davies

**5609/25** – No Disclosures or Declaration of Interests noted / Dim Datgeliadau neu Ddatganiad o Ddiddordeb wedi eu nodi.

**561025** – Previous meeting minutes dated 4<sup>th</sup> November 2025 approved by Cllr Alan Price and seconded by Cllr Dafydd Morgan / Cofnodion y cyfarfod blaenorol dyddiedig 4ydd Tachwedd 2025 wedi'u cymeradwyo gan y Cynghorydd Alan Price ac wedi'u heilio gan y Cynghorydd Dafydd Morgan.

**5611/25** – Clerk informed that Cemetery Fees have been updated with a 10% increase which comes into effect as from 1<sup>st</sup> January 2026. All funeral directors have been emailed a copy / – Hysbyswyd y Clerc fod Ffioedd y Fynwent wedi'u diweddarau gyda chynnydd o 10% a fydd yn dod i rym o 1 Ionawr 2026. Anfonwyd copi at bob trefnydd angladdau drwy e-bost.

**5612/25** – Civility & Respect – Clerk informed that part of the Code of Conduct data, Councils were asked if they had signed up to the Civility & Respect Pledge. Clerk signed up to the pledge and received Certificate No 1960 / Cwrteisi a Pharch – Hysbysodd y Clerc fod rhan o ddata'r Cod Ymddygiad, gofynnwyd i'r Cynghorau a oeddent wedi llofnodi'r Addewid Cwrteisi a Pharch. Llofnododd y Clerc yr addewid a derbyniodd Dystysgrif Rhif 1960.

**5613/25** – Scaffolding Issues (Llangadog Village) – County Cllr Andrew Davies informed that a reply email had been received from Tony Hopkins (Street Works Manager) in regards to the complaint raised to him by retailers and business owners in Llangadog about the extensive scaffolding and traffic control lights which have been installed at Victoria House. Concerns raised that a reduced footfall due to the scaffolding has already had an impact on both the Post Office and Butchers who are directly across from Victoria House. Mr Tony Hopkins (CCC) has requested a Street Works Inspector, plus the scaffolding company traffic management provider to visit and assess the site. He also informed that there was no requirements for consultation or letter-drops to local residents for the use of two-way traffic lights. Await further updates / Problemau Sgaffaldiau (Pentref Llangadog) – Hysbysodd y Cynghorydd Sir Andrew

Davies ei fod wedi derbyn ateb drwy e-bost wrth Tony Hopkins (Rheolwr Gwaith Stryd) ynghylch y gŵyn a godwyd gan fanwerthwyr a pherchnogion busnesau yn Llangadog am y sgaffaldiau helaeth a'r goleuadau rheoli traffig sydd wedi'u gosod yn Nhŷ Victoria. Mynegwyd pryderon bod gostyngiad yn nifer yr ymwelwyr oherwydd y sgaffaldiau eisoes wedi cael effaith ar y Swyddfa Bost a'r Cigydd sydd gyferbyn â Thŷ Victoria. Mae Mr Tony Hopkins (CSC) wedi gofyn i Arolygydd Gwaith Stryd, ynghyd â darparwr rheoli traffig y cwmni sgaffaldiau, ymweld â'r safle ac asesu. Hysbysodd hefyd nad oedd unrhyw ofynion i ymgynghori na dosbarthu llythyrau i drigolion lleol ar gyfer defnyddio goleuadau traffig dwyffordd. Aros am ddiweddariadau pellach.
