**5622/26**– Apologies / Ymddiheuriadau – from Cllr Hugh Davies, Cllr Dafydd Morgan, Cllr Alun Evans and Cllr Alan Price

**5624/26** – Previous meeting minutes dated 2<sup>nd</sup> December 2025 approved by Cllr Wyn Jones and seconded by Cllr Jennifer Hughes / Cofnodion y cyfarfod blaenorol dyddiedig 2 Rhagfyr 2025 wedi'u cymeradwyo gan y Cynghorydd Wyn Jones ac eiliwyd gan y Cynghorydd Jennifer Hughes.

**5625/26**– The Clerk reported that, owing to unforeseen circumstances, Cllr Alun Evans has resigned from his position as Councillor for the Llangadog Ward with immediate effect. Councillors instructed the Clerk to invite expressions of interest from members of the public to fill the current vacancies—two in the Llangadog Ward and two in Dyffryn Ceidrich. / Adroddodd y Clerc, oherwydd amgylchiadau annisgwyl, fod y Cynghorydd Alun Evans wedi ymddiswyddo o'i swydd fel Cynghorydd dros Ward Llangadog gyda effaith ar unwaith. Cyfarwyddodd y Cynghorwyr y Clerc i wahodd mynegiadau o ddiddordeb gan aelodau o'r cyhoedd i lenwi'r swyddi gwag presennol—dau yn Ward Llangadog a dau yn Nyffryn Ceidrich.

**5626/26** - It was resolved that Cllr Wyn Jones will represent the Council at the forthcoming online Annual General Meeting of One Voice Wales, scheduled for Wednesday, 21st January 2026. The Clerk was instructed to formally notify One Voice Wales of this nomination / Penderfynwyd y bydd y Cynghorydd Wyn Jones yn cynrychioli'r Cyngor yng Nghyfarfod Cyffredinol Blyneddol ar-lein Un Llais Cymru, a drefnwyd ar gyfer dydd Mercher, 21ain Ionawr 2026. Cyfarwyddwyd y Clerc i hysbysu Un Llais Cymru yn ffurfiol am y penodiad hwn.

**5627/26 – Precept 2026/2027** - The Council resolved to maintain the precept at £23,000 for the 2026/2027 financial year. The Clerk will submit the signed confirmation form to Carmarthenshire County Council / Dyma'r cyfieithiad Cymraeg: Penderfynodd y Cyngor gadw'r praesept ar £23,000 ar gyfer blwyddyn ariannol 2026/2027. - a. **Llangadog RFC / Clwb Rygbi Llangadog** – An email quotation was received from Ysgol Llangadog regarding the installation of the gate. Councillors confirmed that the gate has already been purchased and are now awaiting confirmation of the installation date. The Clerk was instructed to inform Ysgol Llangadog accordingly / Derbyniwyd dyfynbris drwy e-bost gan Ysgol Llangadog ynglŷn â gosod y giât. d. **Roads & Hedges / Ffyrdd a Gwrychoed** –

- a. Glansevin – potholes
- b. Bryn Heulog (Glan Sawdde) potholes
- c. Nr Railway line – potholes plus drain cover sinking (previously reported)
- d. Garn Goch – Hedge bank wall collapsed onto road
- e. Gwynfe – beyond Bailey Home Farm – potholes as well as from the village towards the school by Bryncoch.
- f. Llangadod - Potholes coming into village (Bran Bridge)
- g. **Road Signs** – CCC agreed to replace the Maes y Wern sign outside the 4 houses in Gwynfe..

h. **Public Lighting** / Goleuadau Cyhoeddus - Concerns have been raised regarding the non-functioning street lights outside Wynstay. The Clerk will investigate and confirm who is responsible for their maintenance / Mae pryderon wedi'u codi ynghylch y goleuadau stryd nad ydynt yn gweithio y tu allan i Wynstay. Bydd y Clerk yn ymchwilio ac yn cadarnhau pwy sy'n gyfrifol am eu cynnal a'u cadw.


