5676/26 – Housing Support Letter – Cllrs discussed further email received from local resident requesting a support letter from LCC to CCC in regards to a council property within Llangadog, , suitable for their household and family needs. County Cllr Andrew Davies has fully supported this request previously and Cllrs also confirmed their support. Clerk to write letter to CCC / Llythyr Cymorth Tai – Trafododd y Cynghorwyr e-bost pellach a dderbyniwyd gan breswlydd lleol yn gofyn am lythyr cymorth gan GSC i GSC ynghylch eiddo cyngor yn Llangadog, sy'n addas ar gyfer anghenion eu cartref a'u teulu. Mae'r Cynghorydd Sir Andrew Davies wedi cefnogi'r cais hwn yn llawn yn flaenorol ac mae'r Cynghorwyr hefyd wedi cadarnhau eu cefnogaeth. Y Clerc i ysgrifennu llythyr at GSC.

5677/26 – Audit Wales Accounts – Clerk confirmed that the accounts had been balanced and all relevant paperwork has been sent to SJ Accounts for audit. Request made for audited accounts to be completed by no later than 30th June / Cyfrifon Archwilio Cymru – Cadarnhaodd y Clerc fod y cyfrifon wedi'u cydbwysu a bod yr holl waith papur perthnasol wedi'i anfon at Gyfrifon SJ i'w harchwilio. 5678/26 – Road Conditions (Llangadog) – County Cllr Andrew Davies informed that a response from DSU had been received in relation to the poor state of the roads in the village and the ongoing issue of the drain by railway line. CCC confirmed that they are aware of the poor conditions and looking at what options are available as financial resources are allocated on a priority and county wide basis, and unfortunately Llangadog has not made the next Capital Resurfacing Programme. CCC will continue to monitor for safety defects, and the drain cover has been issued to a contractor / Cyflwr y Ffyrdd (Llangadog) – Hysbysodd y Cynghorydd Sir Andrew Davies fod ymateb wedi dod i law gan yr Uned Diogelwch Ffyrdd

(DSU) mewn perthynas â chyflwr gwael y ffyrdd yn y pentref a'r broblem barhaus gyda'r draen wrth y rheilffordd. Cadarnhaodd CSG eu bod yn ymwybodol o'r cyflwr gwael ac yn edrych ar ba opsiynau sydd ar gael wrth i adnoddau ariannol gael eu dyrannu ar sail flaenoriaeth ac ar sail y sir gyfan, ac yn anffodus nid yw Llangadog wedi gwneud y Rhaglen Ail-wynebu Cyfalaf nesaf. Bydd CSG yn parhau i fonitro am ddiffygion diogelwch, ac mae'r gorchudd draen wedi'i roi i gontractwr.

- a. Llangadog RFC requested another donation towards coaches for the match being held at the Millenium Stadium. There has been a huge response from supporters to attend, and have already filled places on 6 coaches. Cllrs agreed to another £1,450 towards the costs / a. Gofynnodd Clwb Rygbi Llangadog am rodd arall tuag at goetsys ar gyfer y gêm a gynhelir yn Stadiwm y Mileniwm. Bu ymateb enfawr gan gefnogwyr i fynychu, ac mae lleoedd eisoes wedi'u llenwi ar 6 choets. Cytunodd y Cynghorwyr i £1,450 arall tuag at y costau.
- b. Llangadog Flower Festival – Rachel Evans requested a donation towards the Gwyl Flodau Llangadog Flower Festival currently being organised to be held within the village. Cllrs agreed £100 towards the event / b. Gŵyl Flodau Llangadog – Gofynnodd Rachel Evans am rodd tuag at Wyl Flodau Llangadog sy'n cael ei threfnu ar hyn o bryd i'w chynnal yn y pentref. Cytunodd y Cynghorwyr i roi £100 tuag at y digwyddiad.
