5724/26 – Disclosures or Declaration of Interests noted / Cllr Aaron Hughes, member of Llangadog RFC. 5725/26 – Previous meeting minutes dated 2nd June 2026 approved by Cllr Wyn Jones and seconded by Cllr Dafydd Morgan / Cymeradwywyd cofnodion y cyfarfod blaenorol dyddiedig 2 Mehefin 2026 gan y Cynghorydd Wyn Jones ac fe'u heiliwyd gan y Cynghorydd Dafydd Morgan /

5726/26 – Chair thanked Cllr Aaron Hughes for organising the Chairmans Dinner which was held on 19th June 2026, in the Red Lion, Llangadog / Diolchodd y Cadeirydd i'r Cynghorydd Aaron Hughes am drefnu Cinio'r Cadeirydd, a gynhaliwyd ar 19 Mehefin 2026 yn y Red Lion, Llangadog.

5727/26 – Audited Accounts – Clerk confirmed that the Audited Accounts and all relevant paperwork was sent on Friday 3rd July 2026 / Cyfrifon Archwiliedig – Cadarnhaodd y Clerc fod y Cyfrifon Archwiliedig a'r holl waith papur perthnasol wedi'u hanfon ddydd Gwener, 3 Gorffennaf 2026.

5728/26 – National Lottery Community Fund – CCC had recommended LCC apply for the fund to upgrade the Llangadog Playground as they had no funding available to support this. Clerk completing form and once completed, will forward a draft copy to all Cllrs for approval before sending / Cronfa Gymunedol y Loteri Genedlaethol – Roedd CSC wedi argymhell bod CSC yn gwneud cais am y gronfa i uwchraddio Maes Chwarae Llangadog gan nad oedd ganddynt unrhyw gyllid ar gael i gefnogi hyn. Mae'r clerck yn cwblhau'r ffurflen ac unwaith y bydd wedi'i chwblhau, bydd yn anfon copi drafft at bob Cynghorydd i'w gymeradwyo cyn ei anfon /

5729/26 – Llangadog RFC – Cllrs discussed further the amended Lease, and it was agreed that Cllr Haulwen Booth to contact Telor Dyer to discuss a few issues before

Cllrs approve for signature / Clwb Rygbi Llangadog – Trafododd y Cynghorwyr ymhellach y brydles ddiwygiedig, a cytunwyd y byddai'r Cynghorydd Haulwen Booth yn cysylltu â Telor Dyer i drafod ychydig o faterion cyn i'r Cynghorwyr ei chymeradwyo i'w llofnodi.

5730/26 – Fly Tipping (Black Mountain) – Cllr Haulwen Booth informed that AWS (Llangadog) have agreed to collect rubbish from the area of the Black Mountain. Awaiting further updates if this has been resolved. Cllr Haulwen Booth also recommended that more police presence is needed in that area, not only in regards to fly tipping but also speeding issues / Tipio Anghyfreithlon (Y Mynydd Du) – Dywedodd y Cynghorydd Haulwen Booth fod AWS (Llangadog) wedi cytuno i gasglu sbwriel o ardal y Mynydd Du. Disgwylir am ragor o wybodaeth ynghylch a yw'r mater wedi'i ddatrys. Awgrymodd y Cynghorydd Haulwen Booth hefyd fod angen mwy o bresenoldeb gan yr heddlu yn yr ardal honno, nid yn unig o ran tipio anghyfreithlon ond hefyd o ran materion yn ymwneud â gyrru'n rhy gyflym.

5731/26 – Cllr Dafydd Morgan reported that the Flower Show held, in conjunction with the CP school, had been very successful and that an amount of £7,000 was raised / Adroddodd y Cynghorydd Dafydd Morgan fod y Sioe Flodau, a gynhaliwyd ar y cyd â'r ysgol, wedi bod yn llwyddiannus iawn a bod swm o £7,000 wedi'i godi.

- **Llangadog RFC / Clwb Rygbi Llangadog** – Cllr Haulwen Booth to contact Telor Dyer to confirm items in Lease before Cllrs to approve and sign / Bydd y Cynghorydd Haulwen Booth yn cysylltu â Telor Dyer i gadarnhau'r eitemau yn y brydles cyn i'r cynghorwyr eu cymeradwyo a'u llofnodi.
- **Llangadog Lawn Cemetery** / Mynwent Lawnt Llangadog – Amended Plan 3 received and all Cllrs checked and approved. Clerk to contact Darren Mills to proceed with works involved / Derbyniwyd Cynllun 3 diwygiedig, ac fe'i gwiriwyd a'i gymeradwyo gan yr holl Gynghorwyr. Bydd y Clerc yn cysylltu â Darren Mills i fwrw ymlaen â'r gwaith dan sylw.
 - a. Reported that brambles overgrown. Cllr Wyn Jones confirmed that this was the church responsibility. Clerk to contact June Stait regarding this.
 - b. Hedges require cutting back
 - c. Rubbish behind tool shed
 - d. Still issue with items being placed onto graves and not removed
 - e. Graves still with no headstones in place.
- **Llangadog Playground / Maes Chwarae** – Meeting with Sutcliffe Play on 17th June 2026. In attendance was Gary Parker (Sutcliffe), Cllr Haulwen Booth, Cllr Wyn Jones, Cllr Dafydd Morgan and the Clerk. Discussions on equipment to be upgraded or replaced. Quote received 7th July 2026, and due to the costs involved, it was agreed for the Clerk to apply for the National Lottery Community Fund / Cyfarfod â Sutcliffe Play ar 17 Mehefin 2026. Yn bresennol roedd Gary Parker (Sutcliffe), y Cynghorydd Haulwen Booth, y Cynghorydd Wyn Jones, y Cynghorydd Dafydd Morgan a'r Clerc. Trafodwyd pa offer oedd angen eu huwchraddio neu eu disodli. Derbyniwyd dyfynbris ar 7 Gorffennaf 2026, ac oherwydd y costau dan sylw, cytunwyd y dylai'r Clerc wneud cais i Gronfa Gymunedol y Loteri Genedlaethol.
- **Village Green / Carreg Sawdde Common** – Cllr Wyn Jones informed that he will remove the small area that is fenced off. It was also reported that vehicles were parked on the Village Green, and were having a BBQ. Cllr Wyn Jones suggested putting stone block, so that portable BBQs can be placed on that instead of on the tables and that the entrance that the vehicles came through is blocked. No cars are allowed onto the Village Green / Dywedodd y Cynghorydd Wyn Jones y byddai'n cael gwared ar y darn bach sydd wedi'i ffensiio i ffwrdd. Adroddwyd hefyd bod cerbydau wedi'u parcio ar y Glaswelltir Cymunedol a bod pobl yn cynnal barbeciw yno. Awgrymodd y Cynghorydd Wyn Jones osod bloc cerrig fel y gellid rhoi barbeciwiau cludadwy arno yn hytrach nag ar y byrddau, a rhwystro'r fynedfa a ddefnyddiwyd gan y cerbydau. Ni chaniateir i geir fynd ar y Glaswelltir Cymunedol.

- **Roads & Hedges / Ffyrdd a Gwrychoed –**

- a. Cllr Jennifer Hughes reported to County Cllr Andrew Davis about the hedge overgrowth, by a Council owned farm, Bronallt. Issue to be reported to CCC / a. Adroddodd y Cynghorydd Jennifer Hughes wrth y Cynghorydd Sir Andrew Davis am y gwrych a oedd wedi tyfu'n ormodol ger fferm o'r enw Bronant, sy'n eiddo i'r Cyngor. Rhaid adrodd y mater i CCC.
- b. County Cllr Andrew Davies to report the path leading from outside AWS towards the village as it requires tarmac as currently it is unsuitable for pedestrians / b. Cynghorydd Sir Andrew Davies i roi gwybod am y llwybr sy'n arwain o'r tu allan i AWS tuag at y pentref, gan fod angen tarmac arno; ar hyn o bryd nid yw'n addas i gerddwyr
- c. Clerk informed that a resident reported an issue, about the water flowing down towards his residence and directly onto his drive way. This was reported some years ago, plus over the recent week, and as yet no follow up has been made. County Cllr Andrew Davies to report the issue / c. Hysbysodd y Clerc fod preswlydd wedi adrodd am broblem yn ymwneud â dŵr yn llifo i lawr tuag at ei gartref ac yn uniongyrchol ar ei dramwyfa. Adroddwyd am hyn flynyddoedd yn ôl, yn ogystal ag yn ystod yr wythnos ddiwethaf, ac nid oes camau dilynol wedi'u cymryd hyd yma. Bydd y Cynghorydd Sir Andrew Davies yn adrodd am y mater.
- d. Cllr Jennifer Hughes reported that the current "Llangadog Sign" coming into the village (from the Common) requires cleaning or replacing, as it has become discoloured. County Cllr Andrew Davies to request new sign or CCC to clean / d. Adroddodd y Cynghorydd Jennifer Hughes fod angen glanhau neu ailosod yr "Arwydd Llangadog" presennol sy'n dod i'r pentref (o'r Tir Comin), gan ei fod wedi colli ei liw. Y Cynghorydd Sir Andrew Davies i ofyn am arwydd newydd neu i'r CSC lanhau /
